



Lobo Club Board Meeting Minutes
May 12, 2008

Meeting was called to order at 6:02 p.m. in the Wisdom Room. Board members present were Patty Moreno, Ame Rivera, Ralph Rivera, Carol Hernandez, Nora Robles, and Amanda Brown. Also in attendance were Ms. Hinojosa, Ernest Garcia and Ruth Palacio.

President Patty Moreno reported that the Spring Banquet was a big success and many visiting attendees complimented the Lehman students. Patty discussed Coach Davis' tentative 2008 football kickoff date and Homecoming (September 12, 2008); Pre-season - September 24, 2008 against Del Valle and September 29, 2008 against Hays. Patty informed members of Powder Puff Game and its details.

Prom – Ms. Hinojosa reported that prom was a huge success. Cinderella's Closet created by Rosa Munoz was successful another year. Ms Hinojosa added that this promo was one of the most positive proms.

Lehman Awards – Ms. Hinojosa informed members of the Lehman Awards ceremony, held on May 19, 2008. 9-10th grade: 9:45 a.m. and 11-12th grade: 10:45 a.m.

Graduation Practice – Ms. Hinojosa notified members that graduation practice would be on May 29m, 2008 @ 6:00 p.m. and graduation on May 30, 2008 @ 8:00 p.m.

2007-2008 Audit – Ms. Hinojosa advised the old Board that the audit should be completed for the fiscal year per the Lobo Club Bylaws. There was a lengthy discussion by old Board members in regards to needing more time to gather treasurer report, etc. Ame Rivera and Ruth Palacio to follow-up in June and inform Patty Moreno and Ms. Hinojosa.

Old Board Business – Nora Robles was going to turn in her money but instead was instructed just to deposit into bank account (\$40.00). Members discussed Lobo Club deposits and detailed instructions as to how the deposits are currently processed and deposited. New suggestions were made in regards to all future deposits and how they should be copied and then deposited for good paper trail, per Ms. Hinojosa. To be discussed and voted by the new Board members in the Fall 2008.

Membership – 1) Board members discussed previous detailed sent by Ernest Garcia in regards to Lehman webpage (various software, etc.) and proposal to increase membership from \$5.00 to \$10.00 per person and \$10.00 to \$15.00 per family for 2008-2009 season. A Motion was made and Second by Amanda Brown.
2) Ernest Garcia is still reviewing other websites and will report his findings at the Board meeting in the Fall. Revising the membership form was discussed and will be voted on and revised at next board meeting.

Merchandise – Ralph Rivera informed and presented all Board members the new Lehman vehicle flag that sells for \$20.00. Ralph proposed to Ms. Hinojosa that a run-through be purchased (estimated cost \$4-6k). Ms. Hinojosa shared her concerns in regards to a run-through and its advantages and disadvantages and asked the Lobo Club Board Members to consider donating money for a school marquee. Ralph distributed the new black Lehman sport t-shirt for the 2008 season. Ms. Hinojosa informed members that stadium flags are prohibited per the district policy, but she would check on Homecoming decorations.

Lobo Club Communications – Secretary Ruth Palacio asked about how the Lobo Club solicits to non-member and member athletic parents for their assistance with fundraisers, upcoming banquets, etc. She suggested soliciting and communicating more to parents at games, pep-rallies and fund-raisers to get parents “informed and involved” this way they know what the purpose of the Lobo Club is and that

decisions regarding each sport is not the Lobo Club's decision, it's the coaches' decision on monies are spent. Also she implemented a budget report to be discussed at the next Lobo Club board meeting.

Scholarship – Ame Rivera and Carolyn Hernandez informed board that everyone has been notified and would get information to Patty Moreno by Sunday, May 18, 2008.

Athletic Department – Monetary donation to the athletic department was mentioned. Past donations to Coach Davis will be reviewed. To be further discussed and voted on at next Board meeting.
